Privacy Policy

Robinson India, its subsidiaries and affiliates (hereinafter referred to as "Robinson India", "we") understand that your privacy is important to you and it is equally important to us. We may process your personal data in the capacity of data controllers. We are committed to respecting your privacy and protecting your personal data, which is any information that is capable of identifying you as an individual person.

This privacy policy describes your information that we collect through this website, how that information is used, maintained, shared, protected and how you can update it. It also applies to all personal data received by us from the European Economic Area ("EEA") in any format, including electronic or paper.

We shall process your personal data in accordance with this Privacy Policy, unless such processing conflicts with the requirements of applicable law, in which case, applicable law will prevail.

By submitting your personal data to Robinson India, you acknowledge that:

- a) You have read and understood this privacy policy and agree to the use of your personal data as set out here. Personal Data We Collect

When you use any website of Robinson India for contacting us for product or service related query or to apply for any job openings, your personal data is collected by us. The types of personal data that are collected from you with respect to your enquiry includes your name, company name, contact details, address, and information about your device.

If you apply for a job or opportunity as per your skills through this website, you will be asked to submit your resume. We will use the information in your resume to consider you for the job opening that you specify. We may also use the information in your resume to contact you regarding other opportunities, as per your skills advertised on this website.

We may also collect your personal data from third parties, such as professional recruiting firms, your references, prior employers, Robinson India employees with who have interviewed you and employment background check providers, to the extent this is permitted by applicable law.

We may also ask you for personal data in connection with other interactions you have with this website, including when you answer a survey or report a problem with this website or services offered on this website.

We may use a third-party service provider to assist us with some features of our website. Our service provider will receive your information on our behalf and will not be permitted to use it for any other purpose.

Special category data is a subset of personal data and includes ethnicity, health, trade union membership, philosophical beliefs, sexual orientation, as well as other categories as prescribed by law. Robinson India does not seek to obtain and will not collect such data about a candidate unless permitted to do so by applicable laws.

How We Use Your Personal Data

We collect and use your personal data for legitimate, human resources, business management or commercial reasons. This may include the following purposes:

When We Share Personal Data

- Within Robinson India: Our businesses around the world are supported by Robinson India teams and functions, and personal data will be made available to them if necessary, for the provision of services, account administration, sales and marketing, customer and technical support, business and product development, for instance. All our employees and contractors are required to follow our data protection policy and security policies when handling personal data.
- Our business partners: We occasionally collaborate with other organizations to deliver co-branded Services, to provide content, or to host events, conferences, and seminars. As part of these arrangements, you may be a customer of both Robinson India and of our partners; we may collect and share information about you. We will handle personal data in accordance with the privacy policy.
- Our third-party service providers: We collaborate with and are supported by service providers around the world. Personal data will be made available to these parties only when necessary to fulfil the services they provide to us. E.g. software, system, and platform support; direct marketing services; cloud hosting services; advertising; and order fulfilment and delivery.  - a) To comply with legal obligations and to respond to requests from government agencies, including law enforcement and other public authorities, which may include such authorities outside your country of residence.
 - b) In the event of a merger, sale, restructure, acquisition, joint venture, assignment, transfer, or other disposition of all or any portion of our business, assets, or stock (including in connection with any bankruptcy or similar proceedings.).
